Appropriate resistance-management strategies should be followed.

- Rotate the use of BRACKET® 97 or other Group 3 insecticides within a growing season, or among growing seasons, with different groups that control the same pests.




#### **SOIL APPLICATION METHODS**

Pull back landscape mulch, landscape fabric and surface organic matter prior to making soil applications to ensure solution is delivered to the mineral soil.

Measure the diameter of the tree at breast height (DBH), 4'6" above the soil line. For multi-stemmed trees and shrubs, use the cumulative diameter of individual stems at soil line stead of DBH.

**Basal Soil Injection:** Mix required dosage in sufficient water to inject an equal amount of solution in each hole. For trees less than 8 inches DBH, use a minimum of 4 injection sites per tree. Space injection sites evenly around the base of the tree no more than 12 inches out from the base. Maintain a low pressure and inject into the mineral soil to a depth of two (2) to six (6) inches. Dilution rate may vary depending on equipment used and tree size. Refer to the injector equipment instructions for guidance. [Optional diagram to show injection sites for trees]





**Grid System: For trees less than 15 DBH inches**, use 1/5 oz (5.7 g) per 100 sq. ft. of area under the dripline of the trees or shrubs. Dilute ½ lb (4 oz) (113.4 g) of product in 8 gallons of water to treat 2,000 sq. ft of area under the dripline of the tree or shrub. For trees 15 DBH inches or greater, use 1/5 oz (5.7 g) to 2/5 oz (11.4 g) per 100 sq ft. of area under the dripline of the trees or shurbs. Dilute ½ lbs. (4 oz) (113.4 g) to ½ lbs (8 oz) (226.8 g) of product in 8 gallons of water to treat 2,000 sq. ft. of area under the dripline of the tree or shrub. Make a minimum of four (4) injections per 25 sq. ft. of area under the tree of shrub, using a grid pattern. Apply at least six (6) oz. of dilue solution per injection site. Maintain a low pressure and inject to a depth of six (6) inches.
