GENERAL INFORMATION

OPTIFY® D30 is an easy, one-jug solution containing ammonium sulfate, defoaming agent, drift control agent, and surfactant. This product delivers 3.4 lbs of ammonium sulfate per gallon for superior water conditioning and enhanced herbicide uptake. The drift control agent keeps more product in the field by reducing drift potential across multiple nozzles and tank mix partners. OPTIFY® D30 is also easy to pour, mix, and is low foaming for convenience.

DIRECTIONS FOR USE SHAKE WELL BEFORE USING
